Solvang Bakery Orders Due: Friday, November 3rd

Pick-up Solvang Bakery Orders from St. Mark's: Friday, November 10th, 3-6 pm

Indicate Participation if not ordering from Solvang Bakery: Monday, November 20th

Deliver Decorated House: Wednesday, November 29th, 3 pm-6 pm

Event: Saturday, December 2nd, 4 pm-8 pm

Location (for delivery and event): St. Mark's-in-the-Valley, 2901 Nojoqui Avenue in Los Olivos

1. Bakery/store bought kits may be used. From scratch, homemade houses also welcome. Should you wish to purchase your kit, we encourage you to do so locally at the Solvang Bakery.
2. Inedible decorations can be included (i.e. toys, figures, etc.). You may include a low-wattage electric or battery light in the interior, but we cannot guarantee access to an electric supply source.
3. Entries must be attached to a **rigid** board. The maximum size board is 18" x 18". We recommend using at least a 12" x 12" board.
4. Write a contact name and phone number on the underside of the display board and complete and attach an entry form to your creation.
5. Your entry can be a house, church, barn, historic building, castle or any whimsical structure. We reserve the right to reject any submittal deemed inappropriate for public viewing as this is a family event.
6. All structures are donated to Gingerbread Wonderland for raffle purposes. Should you wish to keep your completed structure after the event a donation of \$200 donation is requested and your house will be marked as "sold" prior to the raffle. The event benefits Arts Outreach and St. Mark's-in-the-Valley Preschool, two non-sectarian, non-profit groups serving children of the Santa Ynez Valley.
7. Judges will award prizes in Individual, Family and Organization/Business categories. For individual entrants prizes will be awarded for Child (8 and under), Youth (9-12), Teen (13-17), and Adult (18+).
8. We reserve the right to photograph entries for promotional purposes; photographs become the property of the Arts Outreach and St. Mark's Preschool.

Houses must be delivered on Wednesday, November 29th between 3 - 6 pm to Stacy Hall, St. Mark's-in-the-Valley Episcopal Church, 2901 Nojoqui Avenue in Los Olivos (on the corner of Alamo Pintado Avenue, one block from the flagpole, next to Mattei's Tavern).
